Wednesday & Friday Membership Draw TERMS & CONDITIONS

The 'Members Draw' Promotion (the Promotion) commences on 12.30pm Wednesday, 19th February 2014 and concludes on 2.15pm on Wednesday, 18th February 2015.

Promotion Entry Eligibility

Tickets for the Promotion will be issued to current financial members of **Port Macquarie Panthers (PMP)** as follows:

- Members who come over to the Raffle Table after 12.30pm on Wednesday and after 5.00pm on Friday's is entitled to receive an entry into the Membership Draw.
- The Member will be provided with an entry ticket and are required to populate their name and member number. They are then required to place the entry ticket in the designated Membership Draw barrel.
- Members can gain entry to this promotion throughout the course of the promotion.
- Only one (1) entry ticket is available per valid financial Membership.

Draw Procedure

- Draws will be conducted every Wednesday and Friday as follows:
 - Wednesday – 5 draws of \$100 cash drawn at 1.00pm | 1.15pm | 1.30pm | 1.45pm | 2.00pm.
 - Friday – 5 draws of \$200 cash drawn at 6.00pm | 6.30pm | 7.00pm | 7.30pm | 8.10pm.
- One name will be drawn from the barrel at the allotted times and the Member whose name is drawn will be announced over the PA system. The Member drawn must be present at the time of the draw and will have 4 minutes in which to present their current Membership Card to identify themselves.
- If the Member whose name is drawn is not present then the draw will continue until a Member whose name is drawn is present.
- No Member can be drawn more than once at the same draw.

Other Terms & Conditions

- Entry is open to members aged 18 years or over who are 2013/14 members of Panthers Group of Clubs.
- Entrants acknowledge that the Promoter is not liable for reimbursement of any prizes otherwise payable to eligible entrants who are in violation of this provision.
- The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age, membership status and place of residence) and to disqualify any entrant whose entry is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- Members who are caught tampering with the entry process in any way, will be refused the right to enter any future promotions in the PMP.
- If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
- Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorized access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of a prize.

- The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities.
