Promotion Entry Eligibility

Tickets for the Promotion will be issued to current financial members of **Port Macquarie Panthers (PMP)** as follows:

- Only Members of the Panthers Entertainment Group are eligible to enter this promotion.
- Members must have their Membership card or proof of Membership and must be a current financial Member of Panthers.
- Panthers Members (Members) are invited to swipe their Membership Cards in the Console provided in the Foyer.
- Members are only able to swipe their card once a day.
- Members will receive an entry ticket which can be placed in the barrel any Thursday or Saturday.
- The Barrel will be placed in the Club's Foyer one (1) hour before each draw.
- Tickets can be added to the barrel during the sessions.
- The details of all winners and prizes will be recorded in the specifically provided register.
- The Promoter is Port Macquarie Panthers, Bay Street Settlement City, Port Macquarie.
- Members must be in the Club to claim the prize.

Promotional Procedure

- An entry will be drawn from the Barrel during the following days and times:
 - Thursday – 12.15pm, 12.30pm, 12.45pm, 1.00pm
 - Saturday – 12.30pm, 1.00pm, 1.30pm, 2.00pm
- One name will be drawn from the barrel at the allotted times and the Member whose name is drawn will be announced over the PA system. The Member drawn must be present at the time of the draw and will have 4 minutes in which to present their current Membership Card to identify themselves.
- If the Member whose name is drawn is not present then the draw will continue until a Member whose name is drawn is present.
- A Member can only win one prize per Swipe 4 Cash session.

Prizes:

- All prizes are in the form of cash.
- Each Swipe for Cash session is valued at \$250 and consists of three (3) draws valued at \$50 and one (1) draw valued at \$100.

- The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age, membership status and place of residence) and to disqualify any entrant whose entry is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- Members who are caught tampering with the entry process in any way, will be refused the right to enter any future promotions in the PMP.
- If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the

right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
