## \$10,000 MEMBERS CASH DRAW

### TERMS & CONDITIONS

Authorised Under NSW Permit No. LTPS/16/08937

The '\$10,000 MEMBERS CASH DRAW' Promotion (the Promotion) commences at 9.00am on Thursday, 10<sup>th</sup> November 2016 and concludes at 12.00pm on Saturday, 31<sup>st</sup> December 2016.

Draws are held at the Port Macquarie Panthers (ABN 57 000 578 398) premises (1 Bay Street, Port Macquarie).

The promotion is available to current financial members of Port Macquarie Panthers (PMP).

The promotion comprises of a (1) Membership Badge Draw & (2) Second Chance Draws.

#### (1) MEMBERSHIP BADGE DRAW

- A badge draw process will take place at the Port Macquarie Panthers premises every Thursday and Friday during the promotional period, whereby a Membership number is randomly selected from the Club Membership database using IGT.
- Badge draw will be conducted between:
  - a. Thursday: 6.00pm – 7.00pm
  - b. Friday: 6.00pm – 7.00pm
- All draws will be announced on the PA system at the Port Macquarie Panthers premises. The winner has 4 minutes to claim their prize.
- It is the responsibility of Members to be in an area of Port Macquarie Panthers premise where they can hear draw announcements.
- The Member will be ineligible if they are not on the Club's licensed premises at the time of the draw, that is if they are contacted after the initial draw and attend the Club to claim the prize.
- If a winner claims the cash prize at the time of the draw, then no second chance draw will take place.
- Prize will start at \$5,000 and if the winner is not present, will jackpot by \$2,000 each week (\$1,000 per draw day). Once the draw reaches \$10,000 the entire amount must be won on that draw day and will go into a Second Chance draw.

#### (2a) SECOND CHANCE DRAW

- A Second Chance Draw will take place in the event that a winner has not won the Badge Draw.
- Second Chance Tickets for the Promotion will be issued to financial Members through the following ways:
  - With any \$10 or more purchase at the Café Paws, Bay Street Brasserie, Paws Bar or Casino Bar (one ticket per eligible transaction, multiple tickets can be earned each day).
  - Swiping Member's Membership Card through the Swipe Kiosk on the day of the draw (one ticket per day).
- Second Chance Entry Tickets will be issued during the following times:
  - Thursday: 9.00am – 6.59pm
  - Friday: 9.00am – 6.59pm
- The Entry Ticket(s) are only valid for the day of the draw.
- The Entry Barrel for the Second Chance Draw will be available for Members to include their entry tickets into every Thursday and Friday from 3.00pm to 6.59pm and will be located at the Casino Bar.
- Members are not permitted to enter promotions on behalf of other Panthers Members.
- Second Chance Draw times will commence between 7.00pm – 8.00pm on Thursday and Friday.
- The prizes awarded every Thursday and Friday are – 2 x \$500 cash prizes.
- A ticket will be drawn from the Second Chance Barrel and will be announced on the PA system at the Port Macquarie Panthers premises. The winner has 4 minutes to claim their prize otherwise a re-draw will take place.
- It is the responsibility of Members to be in an area of Port Macquarie Panthers premise where they can hear draw announcements.
- Members must be present to win and can win multiple times in the Second Chance Draws. Once a ticket has been drawn from the barrel it cannot be put back in the barrel.
- Tickets will be removed from the barrel at the conclusion of the Second Chance Draw each day.

## **(2b) SECOND CHANCE DRAW - \$10,000 Jackpot**

- Once the prize jackpot reaches \$10,000 and no Badge Draw winner is found there will be a Second Chance Draw.
- Entry and draw procedure is the same as the Second Chance Draw.
- Prizes will be 10 x \$1,000.
- A ticket will be drawn from the Second Chance Barrel and will be announced on the PA system at the Port Macquarie Panthers premises. The winner has 4 minutes to claim their prize otherwise a re-draw will take place.

### **OTHER TERMS & CONDITIONS**

- Payments up to \$5,000 will be made in cash and the balance of the prize will be in the form of a cheque that will be issued within 5 working days.
- Entrants acknowledge that the Promoter is not liable for reimbursement of any prizes otherwise payable to eligible entrants who are in violation of this provision.
- The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age, membership status and place of residence) and to disqualify any entrant whose entry is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
- Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorized access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of a prize.
- The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. Entry is conditional on providing this information. Entrants should direct any request to access, update or correct information to the Promoter. All entries become the property of the Promoter.
- If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
