TERMS & CONDITIONS

The 'LUNCHTIME LOOT' (the Promotion) commences at 9.00am on Tuesday, 8th November 2016 and concludes at 12.00pm on Saturday, 31st December 2016.

Draws will be held at the Port Macquarie Panthers (ABN 57 000 578 398) premises (1 Bay Street, Port Macquarie), in either the Gaming Area or at Reception.

PROMOTION ENTRY ELIGIBILITY

- Tickets for the Promotion will be issued to financial Members through the following ways:
 - With any \$10 or more purchase at the Café Paws, Bay Street Brasserie, Paws Bar or Casino Bar.
 - Swiping Member's Membership Card through the Swipe Kiosk daily.
- Entry Tickets will be issued during the following times:
 - Tuesday: 9.00am – 2.29pm
 - Wednesday: 9.00am – 2.29pm
- Members will be required to place their Entry Ticket into the Entry Barrel located in front of the Casino Bar from 12.00pm – 2.29pm. The Entry Ticket is only valid for the day of the draw.
- Entry tickets will be removed from the barrel at the conclusion of each day's draw.
- Members are not permitted to enter promotions on behalf of other Panthers Members.

DRAW PROCEDURE

- Draws times:
 - Tuesday: 2.30pm – 3.30pm
 - Wednesday: 2.30pm – 3.30pm
- Draws will commence at the conclusion of the Hour of Power Promotion.
- There will be 5 draws conducted every 15 minutes, where each winner will be awarded \$50 cash. (Total of \$250 each day. Total of \$500 each week).
- Cut off time for entries into the daily draw is 2.29pm.
- One name will be drawn from the Entry Barrel and the Member whose name is drawn will be announced over the PA system. The Member drawn must personally present their full financial Membership card within 4 minutes of the announcement to claim any prize. The Member will be ineligible if they are not on the Club's licensed premises at the time of the draw, that is if they are contacted after the initial draw and attend the Club to claim the prize.
- It is the responsibility of Members to be in an area of Port Macquarie Panthers premise where they can hear draw announcements.
- If the Member whose name is drawn is not present then the draw will jackpot to the next draw time. On the final draw of the day the draw will continue until a Member whose name is drawn is present.
- Members can win more than once.

OTHER TERMS & CONDITIONS

- The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age, membership status and place of residence) and to disqualify any entrant whose entry is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

- If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
