KENO LOYALTY CARD TERMS & CONDITIONS

Authorised Under NSW Permit No. LTPM/16/00754

The 'Keno Loyalty Card' Promotion (the Promotion) commences at 9.00am on Thursday, 15th December 2016 and concludes at 1.30pm on Wednesday, 26th April 2017.

Members of Panthers will have the opportunity to participate in "Keno Loyalty Card" promotion at their local Panthers club for a chance to win 10,000 Panthers points.

Draws are held at the Port Macquarie Panthers (ABN 57 000 578 398) premises (1 Bay Street, Port Macquarie).

- The promotion is available to current financial members of Port Macquarie Panthers (PMP).
- Members who spend \$10 or more in one Keno transaction at any Keno Cashier will receive one stamp on a Keno Loyalty Card.
- This also applies to any Keno Ticket purchased at a Self-service Terminal – Member will need to see any Keno Cashier and present their purchased ticket to receive a stamp.
- Once all 8 boxes have been stamped, Members need to write their name, membership & phone number on the back of the card and place it in the marked Keno Loyalty barrel (which will be next to the Keno Cashier in the Gaming area).
- On the last Wednesday of each month, we will draw the winner of our Keno Loyalty Card promotion between 1.20pm – 1.30pm.
- Entries into the Barrel close at 1.19pm on the day of the Draw and entries will be removed after the Draw has been completed.
- Members are not required to be present at the time of the Draw to be eligible to claim the prize.
- The Winner will be announced over a PA System, plus will be contacted directly.
- The prize each month is 10,000 Panthers Reward Points which will be directly credited onto the winner's Membership card (within 3 business days).
- Members can win more than once during the promotional period.
- Prizes are non-transferable and cannot be redeemed for cash.
- Any Member caught tampering in any way with the promotion may be refused the right to enter any future Club promotion.

OTHER TERMS & CONDITIONS

- Entrants acknowledge that the Promoter is not liable for reimbursement of any prizes otherwise payable to eligible entrants who are in violation of this provision.
- The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age, membership status and place of residence) and to disqualify any entrant whose entry is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
- Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical

difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorized access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of a prize.

- The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities.
