AN APPLE A DAY PROMOTION TERMS & CONDITIONS

The 'APPLE A DAY' Promotion (the Promotion) commences at 9.00am on Wednesday, 24th May 2017 and concludes when either (a) all Scratchy Tickets have been exhausted or (b) 2.59pm Sunday, 13th August 2017 (whichever occurs first). Draws are held at the Port Macquarie Panthers (ABN 57 000 578 398) premises (1 Bay Street, Port Macquarie).

The promotion is available to current financial members of Port Macquarie Panthers (PMP). The promotion comprises of a (1) Instant Win – Scratchy Tickets & (2) Second Chance Cash Draw.

PROMOTION OVERVIEW – INSTANT WIN SCRATCHY TICKETS

- Members will receive a Scratchy Ticket with the following transactions:
 - With any food & beverage purchase of \$15 or more in a single transaction at any Panthers Port Macquarie Bar or Eatery (one ticket per eligible transaction, multiple tickets can be earned each day).
- There is no limit to the amount of Scratch Tickets a Member can receive in a day, as long as they satisfy the criteria listed above.
- There will be a total of 20,000 Scratchy Tickets available during the promotional period.
- 65 Scratchy Tickets will include the following Major Prizes:
 - Apple MacBook Air 13" 256GB – 5 to be won.
 - Apple iPad Wi-Fi 32GB – 30 to be won.
 - Apple Watch Series 1 – 15 to be won.
 - AirPods – 15 to be won.
- 7,435 Scratchy Tickets which include Instant WIN Prizes to be used within the Club. Examples of this include:

 - \$5 Match & Play Keno Voucher
 - \$5 or \$10 Off Next Purchase - Bay Street Brasserie | Café PAWS
 - FREE Soft Drink
 - FREE Mini Pringles with any purchase in the Casino Bar.
 - Half Price Craft Tap Beer - The TAPP
 - FREE Dessert with any Main Meal Purchase above \$20 – Bay Street Brasserie
 - FREE Gift from Panthers Shop with any purchase greater than \$10
 - TRY AGAIN – Collect another Scratchy Ticket from the Casino Bar.
- 12,500 Scratchy Tickets will include the message SECOND CHANCE CASH DRAW – see below for further details – as this will be the Entry Ticket into the Second Chance Cash Draw.
- Prizes are not exchangeable for cash.

PROMOTION OVERVIEW – SECOND CHANCE CASH DRAW

- Members who receive a Scratchy Ticket with the message SECOND CHANCE CASH DRAW – can use this as an Entry Ticket into the Weekly Second Chance Cash Draw.
- Members will be required to place their Entry Ticket into the Entry Barrel located next to the Casino Bar.
- Entry Tickets can be placed into the Entry Barrel at any time.
- The Second Chance Cash Draw will be conducted every Saturday & Sunday during the promotional period at 3.00pm.
- Tickets remain eligible during each week's draw & will be emptied from the barrel on the conclusion of each Sunday's draw.
- A ticket will be drawn from the Entry Barrel and will be announced on the PA system. The winner has 4 minutes to claim their prize otherwise a re-draw will take place and will continue up to 5 times.

- If no winner has claimed their prize after the fifth draw – the cash amount will jackpot to the next Second Chance Cash Draw.
- It is the responsibility of Members to be in an area of Port Macquarie Panthers premise where they can hear draw announcements.
- Members must be present at the time of the draws to win.
- Once a ticket has been drawn from the Entry Barrel it cannot be placed back in the Barrel.

PROMOTION CONCLUSION

- In the event that the promotion concludes on Sunday, 13th August 2017 and there are Major Prizes (Apple Prizes) that have not be WON – a Draw will be conducted directly after the 3.00pm Second Chance Cash Draw – based on the Entry Tickets that are in the Barrel at that time. Winners must be present to claim their prize. Draws will continue until a Winner has been determined.

OTHER TERMS & CONDITIONS

- Payments up to \$5,000 will be made in cash and the balance of the prize will be in the form of a cheque that will be issued within 5 working days.
- Entrants acknowledge that the Promoter is not liable for reimbursement of any prizes otherwise payable to eligible entrants who are in violation of this provision.
- The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age, membership status and place of residence) and to disqualify any entrant whose entry is not in accordance with these Terms and Conditions or who tampers with the entry process. - If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
- Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorized access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of a prize.
- The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities.
