### **MEGA MONDAY PROMOTION - TERMS & CONDITIONS**

The 'MEGA MONDAY PROMOTION' (the Promotion) commences at 9.00am on Monday, 4<sup>th</sup> November 2019 and concludes at 11.59pm on Monday, 3<sup>rd</sup> August 2020.

Draws will be held at the Port Macquarie Panthers (ABN 57 000 578 398) premises (1 Bay Street, Port Macquarie) front Reception.

#### PROMOTION ENTRY ELIGIBILITY

- Tickets for the Promotion will be issued to current financial members of Port Macquarie Panthers (PMP) when they redeem any MEGA MONDAY \$5.00 Offers, during the promotional period.
- MEGA MONDAY offers will be issued when a Member swipes their Membership Card through the Members Kiosk on Monday'. Offers include:
  - \$5.00 Members Lunch Special
  - \$5.00 Sweet Treat & Coffee (Sweet treat may be changed without notice)
  - o \$5.00 Match & Play Keno (\$5 FREE Keno with a \$5 spend)
  - o 50% off your selection of House Beer / Wine / Spirits (full nip) of Soft drink (1 x per member)
  - o BONUS PRIZE a surprise prize available from the member's kiosk each week. Each surprise prize will only be redeemable 1 x per member and may be changed without notice.
- On redeeming a voucher for any of the above offers the member will receive an entry ticket into the Cash Draw which they will need to include in the Entry Barrel located in front of the Players Bar.
- Entry tickets will be removed from the barrel on the last draw of the day, each Monday.
- Members are limited to 4 Entry Tickets every Monday—but this would require them to purchase all 4 Offers on the one day.
- Members are not permitted to enter promotions on behalf of other Panthers Members.

### **DRAW PROCEDURE**

- Draws will be conducted every Monday during the promotional period at 12.30pm | 1.00pm | 1.30pm
  |2.00pm & 2.30pm.
- There will be 1 draw conducted at each of the designated times, where each winner will be awarded \$50 cash, if they are present at the time of the draws. If the winner is not present at the time of the draw the draw will jackpot to the next draw. On the last draw of the day a winner will be re-drawn every 4 minutes until a winner is present.
- Entry tickets can be placed into the barrel until the last draw at 2.30pm.
- One name will be drawn from the Entry Barrel and the Member whose name is drawn will be announced over the PA system. The Member drawn must personally present their full financial Membership Card within 4 minutes of the announcement to claim any prize. The Member will be ineligible if they are not on the Club's licensed premises at the time of the draw, that is if they are contacted after the initial draw and attend either Club to claim the prize.
- It is the responsibility of Members to be in an area of Port Macquarie Panthers premise where they can hear draw announcements.
