## **MEGA MONDAY PROMOTION - TERMS & CONDITIONS**

The 'MEGA MONDAY PROMOTION' (the Promotion) commences at 9.00am on Monday, 4<sup>th</sup> November 2019 and concludes at 11.59pm on Monday, 3<sup>rd</sup> August 2020.

Draws will be held at the Port Macquarie Panthers (ABN 57 000 578 398) premises (1 Bay Street, Port Macquarie) front Reception.

#### **PROMOTION ENTRY ELIGIBILITY**

- Tickets for the Promotion will be issued to 2019 2020 Financial Members of Port Macquarie Panthers (PMP) when they redeem any MEGA MONDAY \$5.00 Offers, during the promotional period.
- MEGA MONDAY offers will be issued when a Member swipes their current Financial Membership Card through the Members Kiosk every Monday. Offers include:
  - o \$5.00 Members Lunch Special
  - \$5.00 Sweet Treat & Coffee (Sweet treat may be changed without notice)
  - \$5.00 Match & Play Keno (\$5 FREE Keno with a \$5 spend) one voucher per transaction.
  - 50% off your selection of House Beer / House Wine / House Spirits (full nip) of post mix (1 x per member)
  - BONUS PRIZE 1x bonus prize will be available from the member's kiosk each Monday. It may be changed without notice.
- On redeeming a voucher for any of the above offers, the member will receive an entry ticket into the Cash Draw.
- Members will be required to place their entry ticket into the designated entry barrel at the Players Bar
- Members are limited to 4 Entry Tickets every Monday. This would require them to purchase all 4 Offers.
- Members are not permitted to enter promotions on behalf of other Panthers Members.
- In the event that an Entry Ticket does not automatically generate from the point of sale, it will be up to the discretion of the Duty Manager to provide the member with an Entry Ticket. Member details will be documented and eligible transaction receipt will be kept on file for verification.

### DRAW PROCEDURE

- There will be 1 draw conducted at each of the designated times. Each winner will be awarded \$50 cash. A total of \$250 each Monday.
- An Entry Ticket will be drawn from the Entry Barrel at the time listed above.
- The Member's Name & Membership Number will be announced over the Club's PA system.
- The Member drawn will have 4 minutes to present themselves along with their 2019/2020 Financial Membership Card to the Promotional Staff Member conducting the Draw.
- The Member will be ineligible if they are not on the Club's licensed premise at the time of the draw when their name is announced.
- It is the responsibility of the Members to be in an area of Port Macquarie Panthers premise where they can hear draw announcements.
- Members are not permitted to enter promotions on behalf of other Panthers Members.
- Guests of the Club are not eligible to participate in the promotion.
- Once a ticket has been drawn from the barrel it cannot be put back into the barrel.

- The barrel will be emptied after the final draw each Monday.
