PORT MACQUARIE PANTHERS BONUS WEEKLY CASH DRAW - TERMS & CONDITIONS

The 'BONUS WEEKLY CASH DRAW' promotion (the Promotion) commences at 9am Tuesday 8 September and concludes at 8pm Tuesday 27 October 2020.

Draws will be held at the Port Macquarie Panthers (ABN 57 000 578 398) premises (1 Bay Street, Port Macquarie).

PROMOTION ENTRY ELIGIBILITY

- Promotion is open to renewing members, new members and life members of Penrith Rugby League Club Limited.
- One 'Bonus Weekly Cash Draw' entry will be given to life members and each member over the age of 18 years who renew their membership for 2020/21 or join as a new member.
