TERMS & CONDITIONS

Authorised Under NSW Permit No. TP/00211

The 'MEMBERS CASH DRAW' Promotion (the Promotion) commences at 7.45pm February 4 2021 and concludes July 1 2021.

Draws are held at the Port Macquarie Panthers (ABN 57 000 578 398) premises (1 Bay Street, Port Macquarie). The promotion is available to current 2021 financial members of Port Macquarie Panthers only.

The promotion comprises of a (2) Membership Badge Draws

(1) MEMBERSHIP BADGE DRAW

- A badge draw will take place at Port Macquarie Panthers every Thursday during the promotional period at 7:45pm
- A membership number is randomly selected from the Club Membership database using IGT then the standard draw protocol is to be followed.
- The prize will start at \$1,000 and if the winner is not present, will jackpot by \$1,000 each draw. Once the prize reaches \$5,000 and the member is not present, the entire amount must be won on that draw day and will go into a Second Chance draw (2b).

(2b) SECOND CHANCE DRAW - \$5,000 Jackpot

- Once the prize jackpot reaches \$5,000 and no Badge Draw winner is found, a 5 X \$1,000 Second Chance Draw will take place.
- Second Chance Entries will be issued from 9am the Friday prior to the Second Chance Draw until 7.45pm on the day of the Second Chance Draw. Entries will be issued as follows;
 - With every \$10 spent at KOVE Kitchen, Café & Bar, Players Bar and The TAPP. Tickets will print and be given to the customer to place into the barrel.
- The Second Chance Barrel will be located near reception from 4:00pm on the day of the second chance draw. Members must place their second chance tickets in the barrel by 7:45pm.
- At 8:00pm the 5 x \$1,000 Second Chance members draw will commence. Tickets will be drawn from the Second Chance Barrel. The draw protocol below will be followed. If after 4 minutes a member is not present for one of the \$1,000 second chance draws a redraw will occur until a winner is found.
- Members can win more than once.
- **Tickets are valid the week of issue only.**

DRAW PROTOCOL

- The Members Name & Membership Number will be announced over the Club's PA system.
- The Member drawn will have 4 minutes to present themselves along with their 2021 Financial Membership Card to the Promotional Staff Member conducting the Draw.
- The Member will be ineligible if they are not on the Clubs licensed premise at the time of the draw when their name is announced.
- It is the responsibility of the Member to be in an area of Port Macquarie Panthers where they can hear draw announcements.

OTHER TERMS & CONDITIONS

- Members will not receive entry tickets on purchases paid for with prize cards.
- Members are not permitted to enter promotions on behalf of other Panthers Members.
- Guests of the Club are not eligible to participate in the promotion.

- Payments up to \$5,000 will be made by cash or cheque that will be issued within 5 working days.
- Entrants acknowledge that the Promoter is not liable for reimbursement of any prizes otherwise payable to eligible entrants who are in violation of this provision.
- The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age, membership status and place of residence) and to disqualify any entrant whose entry is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
- Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorized access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of a prize.
