

Members Free Cash Giveaway

Tickets for the promotion will be issued to current financial members of Port Macquarie Panthers only in the following manner:

Members must visit one of the membership swipe kiosks in the foyer between 9.00am – 6:15pm on Thursday’s and swipe their current financial member’s card to receive a Free Members Cash Giveaway ticket.

Members can earn extra tickets for every \$20 spent on F&B on any Thursday during the promotional period. \$20 purchase must be in 1 transaction at the following, The Kove Kitchen, The Kove Café, The Kove Bar, The TAPP Bar & Players Bar.

Tickets cease printing at 6:15pm every Thursday during the promotional period.

It is the responsibility of the members to place their tickets into the marked barrel.

Members Giveaway will be conducted from 6:30pm – 8pm.

All winners will be notified by the clubs P.A system which is audible across Main Gaming Area, Outdoor smoking terraces, and The Kove & The TAPP dining area.

Winners will have 4 minutes from the time their number is called to claim their prize. If they do not claim their prize within 4 minutes, we will redraw the number until a winner is found.

Winner must be on site at the time of the draw to be eligible to win.

The promotion will be conducted from the promotions desk. Winners will be asked to go to the promotions desk to claim their prize.
