

PICK A PLAYER - TERMS & CONDITIONS

Pick A Player (the Promotion) commences **9:00am Thursday, 12th March 2026, to 7:30pm Thursday, 2nd April 2026** (promotional period).

The promotion will be held at the Panthers Port Macquarie (ABN 57000578398) premises (1 Bay Street, Port Macquarie NSW 2444).

PROMOTION OVERVIEW

- Members swipe their membership card at the swipe kiosk every day during the promotional period and receive a ticket to be placed in the marked barrel.
- Members will receive one (1) ticket each day they visit and swipe with members card.
- Members will receive one (1) bonus ticket for every \$20 spent at The Kove Kitchen during the promotional period when they swipe their members card.
- Members receive one (1) bonus ticket for every \$10 spent at The Kove Bar, The TAPP Bar & The Players Bar during the promotional period.
- It is the responsibility of the members to place their tickets into the marked barrel.
- All tickets must be placed in the marked barrel by 7:30pm on Thursday, 2nd April 2026.
- Winners will be drawn at 7:45pm on Thursday, 2nd April 2026.
- Winners must be present to play Pick A Player.
- Each winner will be given the chance to play Pick A Player to win a share of \$10,000 worth of cash.
- Promotion is open to all members who swipe during the promotional period.
- Winners have 4 minutes to present their membership card to the promotions host to play Pick A Player.
- There will be 10 player heads, each with a specific prize amount hidden on the other side. Winners will get a chance to pick a player's head and reveal the amount they have won.
- Prize amount breakdown:
 - 1 x \$5,000
 - 1 x \$2,000
 - 1 x \$1,000
 - 1 x \$500
 - 6 x \$250 each
 - (\$10,000 total)
- Promotion can be withdrawn at any time without notice.

OTHER TERMS & CONDITIONS

- Entrants acknowledge that the Promoter is not liable for reimbursement of any prizes otherwise payable to eligible entrants who are in violation of this provision.
- The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age, membership status and place of residence) and to disqualify any entrant whose entry is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

- The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities.
