TERMS & CONDITIONS

Authorised Under NSW Permit No. TP/14783

The '\$30,000 MEMBERS DRAW' Promotion (the Promotion) commences at 9.00am Friday, 17th April 2026 and concludes at 9.30pm on Friday, 9th October 2026.

Draws are held at Panthers Port Macquarie (ABN 57 000 578 398) premises (1 Bay Street, Port Macquarie). The promotion is available to current Financial members of Panthers Port Macquarie only.

The promotion comprises of 3 parts:

(1) \$30,000 MEMBER DRAW

- A draw will take place at Port Macquarie Panthers every Friday during the promotional period at 6.30pm and 8.15pm.
- Members will be automatically entered into the draw if they hold a Financial Panthers Port Macquarie Membership (includes Pending Approval).
- A Membership Number is randomly selected from the Club Membership database using IGT.
- The Members Name & Membership Number will be announced over the Club's PA system.
- The Member drawn will have 4 minutes to present themselves along with their Financial membership card | Pending Approval Panthers Port Macquarie Membership Card to the Promotional Staff Member conducting the draw.
- The Member will be ineligible if they are not on the Clubs licensed premises at the time of the draw when their name is announced.
- It is the responsibility of the Member to be in an area of Panthers Port Macquarie where they can hear draw announcements.
- The prize pool will start at \$10,000 and if the winner is not present, the jackpot will increase by \$500 after each draw.
- If the Draw is won prior to reaching \$30,000 during the promotional period, the jackpot amount will revert back to \$10,000 for the next draw.
- When the jackpot reaches \$29,500 and if the Member drawn is not present, the next draw will be a \$30,000 Jackpot Draw and the entire jackpot must be won.

(2) WEEKLY SECOND CHANCE CASH DRAW

- A Second Chance Draw will occur directly after the 8.15pm draw if the Weekly Members Draw is not won for \$1,000 (2x \$500 draws).
- One Entry Ticket into the Second Chance Draw will be available every Friday from 9.00am to 7.50pm with any food or beverage purchase above \$10 at KOVE Kitchen, KOVE Café, KOVE Bar, Players Bar and The TAPP (only one Entry Ticket per Member).
- Entry Ticket is only valid on the date of issue.
- Lost Entry Tickets will not be replaced.
- If in the event an Entry Ticket is not generated, the issue must be reported at the time of purchase to a Duty Manager.
- Members must place their Entry Ticket in the Second Chance Draw Entry Barrel located at Reception on the day of the draw between 9am and 8.00pm.
- Two (2) Entry Tickets will be drawn from the Second Chance Barrel and continue until winners are found.
- There will be Two (2) winners, each winner receiving a \$500 cash prize.
- The Members Name & Membership Number will be announced over the Club's PA system.

- The Member drawn will have and 4 minutes to present themselves along with their Financial Membership card | Pending Approval Panthers Port Macquarie Membership Card to the Promotional Staff Member conducting the Draw.
- The Member will be ineligible if they are not on the Clubs licensed premises at the time of the draw when their name is announced.
- It is the responsibility of the Member to be in an area of Port Macquarie Panthers where they can hear draw announcements.
- The Second Chance Entry Barrel will be emptied on the conclusion of each Friday's Draw.

(3) \$30,000 Members Jackpot Draw

- Once the Weekly Members Draw reaches \$30,000 and the winner drawn is not present, a \$30,000 Second Chance Draw will take place for 6x \$5,000 cash prizes.
- One Entry Ticket will be available from 9am to 7:50pm on the day of the Draw with any \$10 Food or Beverage spend at KOVE Kitchen, KOVE Café, KOVE Bar and The TAPP (only one Entry Ticket per Member).
- This Entry Ticket is only valid on the date of issue.
- Lost Entry Tickets will not be replaced.
- If in the event, an Entry Ticket is not generated, the issue must be reported at the time of purchase to a Duty Manager.
- The \$30,000 Second Chance Entry Barrel will be located near Reception or the Raffle Table from 9.00am to 8.00pm on the day of the draw.
- An Entry Ticket will be drawn from the Second Chance Barrel and continue until a winner is found.
- The Members Name & Membership Number will be announced over the Club's PA system.

OTHER TERMS & CONDITIONS

- Any jackpot amount available on the conclusion of the promotion will be carried forward to the next Members Draw.
- By participating, entrants agree to be bound by these terms and conditions.
- Members will not receive an Entry Ticket on purchases paid for with prize cards.
- Members are not permitted to enter promotions on behalf of other Panthers Members.
- Guests of the Club are not eligible to participate in the promotion.
- If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Club, the Club reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
- Except for any liability that cannot be excluded by law, the Club (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Club's control); (b) any theft, unauthorized access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Club) due to any reason beyond the reasonable control of the Club; (d) any variation in prize value to that stated in these Terms and

Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of a prize.

- Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- The Club reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age, membership status and place of residence) and to disqualify any entrant whose entry is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Club's discretion. Failure by the Club to enforce any of its rights at any stage does not constitute a waiver of those rights.
