- Members swipe their membership card at the swipe kiosk every Wednesday to receive their ticket(s) to be placed in the barrel.
- Members will receive 1 ticket for every \$20 spent at The Kove Kitchen every Wednesday until 6.15pm
- BONUS TICKET members receive 1 Ticket for every \$10 spent at The Kove Bar, The TAPP Bar & The Players Bar every Wednesday until 6.15pm.
- It is the responsibility of the members to place their tickets into the marked barrel.
- Winners will be drawn at the following times: 6:30pm, 6:45pm, 7pm, 7:15pm, 7:30pm, 7:45pm, 8pm, 8:15pm
- Each winner will be given the chance to play Colossus to win a share of \$1,500 worth of cash.
- Promotion is open to all members who swipe on Wednesdays during the promotion period.
- Winners have 4 minutes to present their membership card to the promotions host to play Winter Wonderland.
- Winners will be asked to play Colossus in the Promotions area of Panthers Port Macquarie.
